SUBJECT: COMPLIANCE WITH CONSTITUTIONAL AND LEGAL OBLIGATIONS REGARDING EXECUTION OF POWER OF ATTORNEY OF IMRAN KHAN FOR FILING AN APPEAL BEFORE THE SUPREME COURT OF PAKISTAN.

Mr. Baig,

That, the undersigned, Khalid Yousaf Chaudry, Advocate High Court, the duly authorized legal counsel for Imran Khan, who is presently confined under your authority in Central Jail Adiala, Rawalpindi, in connection with NAB Reference No. 19/2023 and Special Court Case No. SJC-1/T/2024, I have been entrusted by former prime minister Imran Khan with responsibility to appear, follow, manage, coordinate, and pursue multiple legal proceedings on his behalf and , representing him before the Court Camp Adiala jail and other Courts of Pakistan and also Member-Legal for Imran Khan Cases to Core Committee PTI.

That a contempt petition on behalf of prisoner Imran Khan is required to be filed before the Supreme Court of Pakistan in an order passed by the Supreme Court dated 18.08.2026. (Copy of Order enclosed). For this purpose, execution of the Power of Attorney by the prisoner/petitioner is indispensable and in this regard, Mr. Imran Ahmed Khan Niazi engaged Mr. Uzair Karamat Bhindari as his counsel for Supreme Court and he is also representing Mr. Khan in main case.

That I personally visited the premises of Central Jail Adiala on 20th August 2026, carrying the requisite three Power of Attorney for the Supreme Court in order to obtain the signatures of Mr. Imran Khan. when I reached Gate No. 5 of Jail where Mr. Khan matters handle. At Gate No. 5, my name was duly noted by jail staff, and I was asked to wait for permission. Despite repeated follow-ups, the power of attorney was neither forwarded to Mr. Imran Khan and nor received for execution by you.

That Your willful failure to ensure execution of the Power of Attorney is directly obstructing enforcement of the prisoner's fundamental right of access to justice and his right to approach the Supreme Court of Pakistan. Such conduct constitutes a violation of the Constitution of the Islamic Republic of Pakistan, applicable laws, and Jail Rules. And your inaction and failure to perform your statutory duties as Superintendent of Jail, thereby impeding the lawful exercise of

legal rights of Imran Khan, amounts to gross misconduct, dereliction of duty, and abuse of authority and i am enclosing herewith the three Power of Attorney along with the requisite legal documents. It is further necessary to bring into your knowledge that an affidavit regarding above facts already submitted in Supreme Court in contempt petition filed by Dr. Uzma Khan.

You are hereby called upon, in the strongest legal terms, to ensure that within twenty-four (24) hours, the Power of Attorney for Supreme Court (enclosed) present before Mr. Imran Khan for execution of his signatures and thumb impression, and that the duly executed Power of Attorney are returned to the undersigned within twenty-four hours to enable filing petition before the Supreme Court.

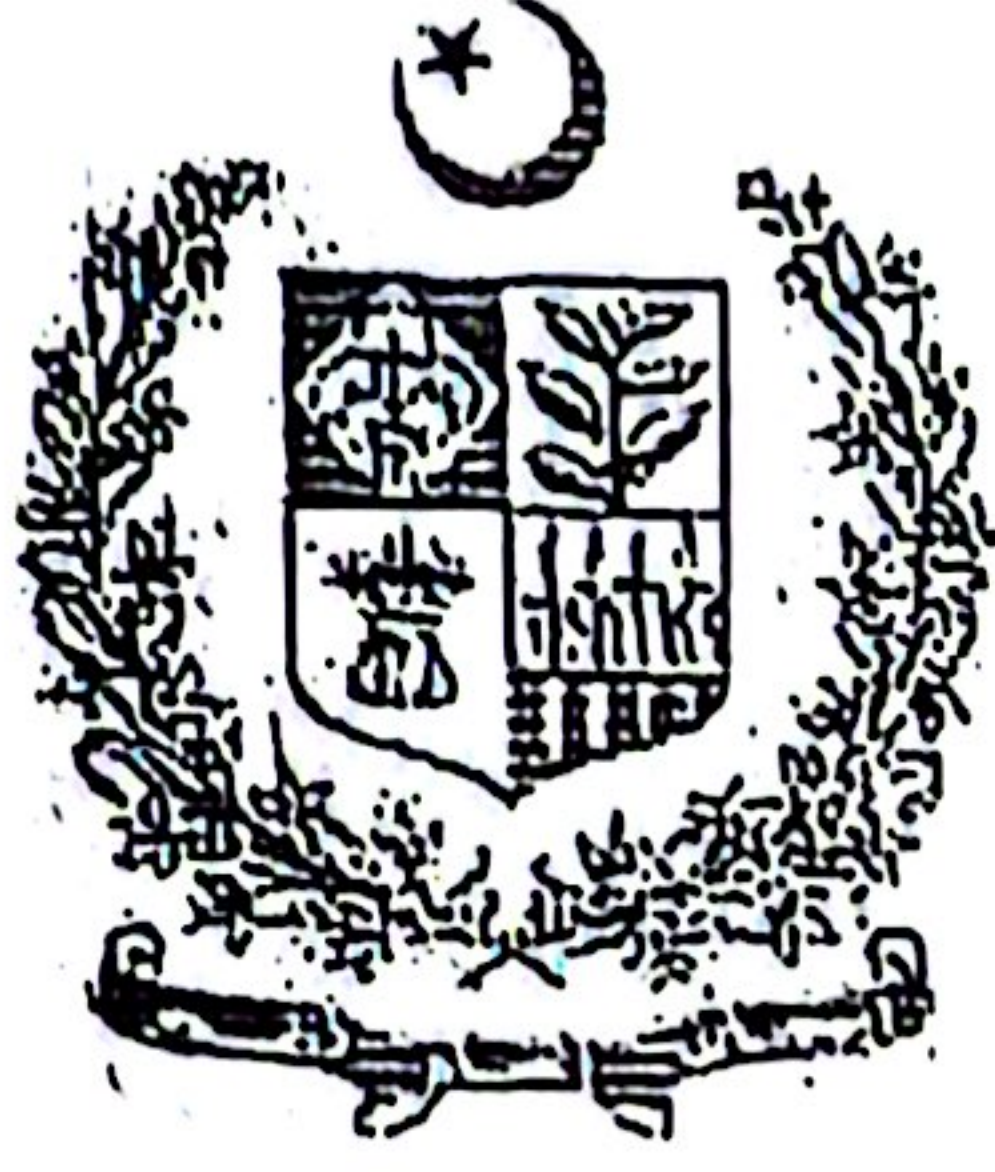

1. That former Prime Minister Imran Khan, who is presently confined in Adiala Jail in connection with NAB Reference No. 19/2023, has assigned me responsibility for his legal matters.

That on the instructions of Mr. Uzair Karamat Bhandari, Advocate/Counsel for Imran Ahmad Khan Niazi, and for the purpose of obtaining the signatures of Imran Ahmad Khan Niazi on the Power of Attorney/Vakalatnama for filing a Contempt of Court Petition in relation to the order of the Supreme Court of Pakistan dated 18.08.2026, I reached Adiala Jail at about 12:30 p.m. at Gate No. 5.
3. That I introduced myself to the jail authorities and submitted the Vakalatnama along with the relevant documents. However, the jail authorities asked me to wait and did not receive the Vakalatnama.
4. That the jail authorities also did not arrange for the Vakalatnama to be presented to Imran Ahmad Khan Niazi for obtaining his signatures. As a result, the Vakalatnama was neither received by the jail authorities nor signed by Imran Ahmad Khan Niazi.
5. That I am making this affidavit to place the above facts on record.
6. That the contents of this affidavit are true and correct to the best of my knowledge and belief.
